Bidder Auction Agreement Information

Rates & Fees

7% of high bid for SOLD vehicle \$199 pre-delivery service fee plus applicable tax, tag, and title required by the State of Florida

Bidder information

Any bidder that**IS NOT** a registered dealer will be required to pay a \$500 bidder deposit. Dealers will be required to show their auction access cards and have a valid membership

Registration must be completed atleast 24 hours prior to auction to ensure proper completion. Any application received the day of sale my not be processed in time to participate.

General Rules

- 1. Zephyrhills Classic Car Auction is performing an auction service and is responsible only for their guarantees set forth and is referred to as an Auction Company.
- 2. Purchaser agrees to accept the ownership of the item at the fall of the hammer and he or she will assume all responsibility and liability for the item at that time and without disputes.
- 3. Bidder's Application: Agrees that all the information given is correct and valid. Any invalid information given such as false ID, or false contact information will have to correct the information before the auction starts otherwise, they will not be able to be permitted in the auction.
- 4. All transactions are to abide by the Laws and Rules of Uniform Code of the state in which the sale is held.
- 5. All bids are to be per lot unless otherwise mentioned by the Auctioneer.
- 6. The highest bidder is to be the buyer. In all cases of conflicting bids, the auctioneer will use his judgment as to the good faith of all claims and his decision is final for the lot that is being presented on the block at the time of the conflicting bid.
- 7. Bidders are required to register and give identification before bidding and are required to use the bidder number given to them when completing a bid on lot. Every lot that is purchased will have an itemized invoice to be given one to the buyer and one to the seller.
- 8. Automobiles are shown on the block by the number given to each lot. The auctioneer will accept bids from the bidders present in the room. The auctioneer has the right to place a bid for consignor up to the reserve amount. The consignor has the right to raise or lower the reserve price where it will be sold to the highest bidder at the time of the last bid given when the reserve has been raised or lowered, the auctioneer will announce it before the speaker announcing the item begins.
- 9. The seller will have every opportunity to view all lots prior to sale. However, the purchaser must understand that he/she is buying property entirely upon his/her own examination and opinion. All lots as sold "AS IS." Any guarantees written or implied to the authenticity, originality, or condition of any lot are not the responsibility of the Auction Company and should be determined by the purchaser's own inspection and discretion.
- 10. SHOULD any dispute arise after the sale; the auctioneer's records shall be reviewed and determine by the auctioneer.
- 11. Zephyrhills Classic Car Auction IS NOT RESPONSIBLE FOR LOST, STOLEN, OR DAMAGED PROPERTIES.
- 12. Zephyrhills Classic Car Auction will have an area for the cars to be viewed or examined before the auction begins. Each area is specified for each and every vehicle permitted to be in the auction sponsored by Zephyrhills Classic Car Auction
- 13. Zephyrhills Classic Car Auction is entitled to Consignor/Bidder premium of 7% on any vehicle sold due to the Zephyrhills Classic Car Auction auto event up to the next 30 days after the events is completed.
- 14. Upon being the highest bid, you are responsible to pay the hammer price plus the auction premium. Non-payment will deem you liable for any losses incurred in the auction plus any legal action that is taken against you for non-payment of the purchased vehicle that you are the high bid on the vehicle.
- 15. If the buyer fails to comply with any of these General Rules and Terms Zephyrhills Classic Car Auction, in addition to asserting all remedies available by law including the right to hold such defaulting buyer liable for the purchase price cancel the sale, retaining as liquidated damages any payment made by the buyer, resell the property with reserve at the auction again, but the premium will be redetermined and discussed before the lot is to go back on the block to cover the damages. Also, the final decision of this matter is final no other changes will be made to this.
