### Vehicle Restrictions Information

1. All vehicles with working fuel gauges should have only 1/4 tank of fuel. (Any vehicle with inoperative fuel gauge should call 727-233-9799 for further instructions.)
2. All vehicles must run and drive under their own power
3. During the auction, no vehicle can be started or driven. NO EXCEPTIONS.
4. Sold vehicles WILL NOT be released until 30 minutes after the end of auction that day
5. All vehicles NOT SOLD must be picked up within 48 hours after close of auction.

**All vehicles not meeting these restrictions will be subject to an additional \$100.00 service fee**

### Title Information

- The VIN on your vehicle **MUST** match your title. Our inspection team at the auction **MUST** be able to read the VIN to verify that it matches your title. If the vehicle is home built or custom, please check with your local DMV to ensure you have a valid VIN and title.
- If you are a private seller **the title MUST be in your name.**
- If you are representing the seller, the title **MUST** have a re-assignment space or an applicable state re-assignment form, and you **MUST** have a completed and signed Power of Attorney form completed by the owner of the vehicle and assigned to your name.
- If you are an auto dealer, the title **MUST** have a re-assignment space or an applicable state re-assignment form.
- If your vehicle is part of a trust, the title and executor paperwork and a copy of the death certificate **MUST** be submitted
- If the vehicle had a lien, it must be satisfied and properly noted on the title.
- The original title must be delivered to the auction office at the time of vehicle check-in
- If you are claiming actual miles, the actual miles **MUST** be shown on the title.

**IT IS YOUR RESPONSIBILITY AS THE SELLER TO VERIFY THE VIN ON THE VEHICLE AND TITLE BEFORE ATTENDING THE AUCTION.**

**ON THE DAY OF CHECK-IN AT THE AUCTION, IF YOUR TITLE DOES NOT MEET THE REQUIREMENTS LISTED ABOVE, YOU WILL FORFEIT YOUR CONSIGNMENT FEE AND NUMBER, AND THE VEHICLE MUST BE REMOVED FROM THE AUCTION PROPERTY IMMEDIATELY.**
